USED VEHICLE SERVICE DISCOUNT AGREEMENT

In consideration of the sum of \$ _____ paid to Cadott Auto Sales (DEALER) by OWNER, and subject to the terms, conditions, limitations, and exclusions hereof, DEALER agrees to provide OWNER with a discount of 50% (50 percent) from DEALER'S established regular retail cash price for all parts, accessories and labor furnished, or sublet, by DEALER in the repair of the above-described VEHICLE.

The TERM OF THIS AGREEMENT, during which the DEALER will provide the foregoing discount, shall commence on the DATE OF PURCHASE above set forth and shall continue for the period of _____ following such DATE OF PURCHASE.

THE SERVICE DISCOUNT PROVIDED BY THIS AGREEMENT DOES NOT EXTEND OR APPLY TO:

1. Repairs which are covered by an existing DEALER or manufacturer's warranty or which the manufacturer has publicly announced it will make pursuant to a recall of the vehicle.
2. Lubrication, gasoline, oil changes, car washing, replacement of tires, towing, road service or storage.
3. Repairs made necessary as a result of negligence, misuse, and failure to perform required servicing as specified by the manufacturer.
4. Collision, accident, fire, or other casualty, unless covered by insurance.

DEALER SHALL NOT BE RESPONSIBLE OR LIABLE FOR THE LOSS OF THE USE OF THE VEHICLE, LOSS OR TIME, INCONVENIENCE, COMMERCIAL LOSS OR OTHER INCIDENTAL AND CONSEQUENTIAL DAMAGES.

The service discount provided by this agreement pertains only to parts, accessories and labor furnished by DEALER, with respect to the above-described VEHICLE, at the DEALER'S SERVICE DEPARTMENT located at the DEALER'S address above set forth. Normal policy of DEALER is to mark up parts and sublet repairs by 100%.

This agreement is personal to the above-named OWNER and is not assignable or transferable to or enforceable by any other person.

OWNER'S copy of this Service Discount Agreement must be presented to DEALER at the time OWNER requests repairs to be made otherwise OWNER will not be entitled to receive the discounts herein.

THIS AGREEMENT IS SOLELY AN AGREEMENT THAT PROVIDES FOR A DISCOUNT ON PARTS, ACCESSORIES AND LABOR UNDER THE TERMS SET FORTH ABOVE. IT IS NOT A WARRANTY. BY THIS AGREEMENT, DEALER DOES NOT REPRESENT OR PROMISE THAT THE VEHICLE TO WHICH IT PERTAINS IS DEFECT FREE OR WILL MEET A SPECIFIED LEVEL OF PERFORMANCE. OWNER WILL RECEIVE THE DISCOUNT PROVIDED BY THIS AGREEMENT WITHOUT REGARD TO WHETHER THE REPAIRS PERFORMED RELATED TO DEFECTS OF WORKMANSHIP OR MATERIAL OR ANY OTHER CAUSES, EXCEPT THOSE CAUSES AS ARE HEREIN EXPRESSLY EXCLUDED.
